

WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. In consideration for participating in _____ and other valuable consideration, I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE Our Savior Lutheran Church, School, or any other related entities, their officers, servants, agents, and employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by many participants, or to any property belonging to me or any participant, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in such activity/event, or while in, on or upon the premises where the activity/event is being conducted or in transportation to and from said premises.
2. To the best of my knowledge, myself and all participants can fully participate in this activity/event. I am fully aware of risks and hazards connected with the activity/event/event, including but not limited to the risks as noted herein, and I hereby elect to voluntarily to participate in said activity/event, and to enter the above-named premises and engage in such activities at this location. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by any participants, or any loss or damage to property owned by any participant, as a result of being engaged in such an activity/event, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES or otherwise.
3. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASEES from any loss, liability, damage or costs, including court costs and attorney's fees, that may incur due to my participation in said activity/event, including the travel to activity/event, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise.
4. To the fullest extent permitted by applicable law, I hereby forever RELEASE, WAIVE, DISCHARGE, AGREE TO INDEMNIFY, HOLD HARMLESS AND COVENANT NOT TO SUE THE CHURCH/SCHOOL, ITS OFFICERS, DIRECTORS, EMPLOYEES, AGENTS, AND ASSIGNS, FROM ALL LIABILITY TO ME, OR ANY PARTICIPANTS, OUR PERSONAL REPRESENTATIVES, ASSIGNS, HEIRS, AND NEXT OF KIN, FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIMS OR DEMANDS THEREOF, ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF MY CHILD, RELATED TO OR ARISING FROM TRANSPORTATION OF MY PARTICIPANTS TO/FROM THE ACTIVITY/EVENT.
5. I UNDERSTAND THAT our Savior Lutheran Church and School and related entities WILL NOT BE RESPONSIBLE FOR ANY MEDICAL COSTS ASSOCIATED WITH AN INJURY MY PARTICIPANTS MAY SUSTAIN.

6. I ALSO UNDERSTAND THAT I AM RESPONSIBLE FOR ANY DAMAGE ANY PARTICIPANTS CAUSE TO THE FACILITIES.

IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
